#### **GENERAL PROVISIONS.**

Sports competitions are held in accordance with the rules for the sport of "Wrestling", approved by the order of the Ministry of Sports of the Russian Federation No. 906 dated 05.11.2019.

Sports competitions are held for the purpose of development of wrestling in the Russian Federation. The objectives of holding sports events are:

- identification of the strongest athletes of the Russian Federation;
- selection of athletes for national sports of the teams Russian Federation for international prepare competitions and participate in the World Championship on behalf of the Russian Federation;
- Assignment of titles, categories (CMC, MS, Honorary MS, Orders) according to the regulations.
- exchange of experience in the field of physical culture and mass sports, preservation of sports traditions.

It is prohibited exert illegal influence on the results of sports to competitions included in regulation this on interregional and all-Russian official sports competitions. It is prohibited participate in offices gambling in bookmakers and sweepstakes bv making on official sports competitions in accordance with the requirements established by item 3 of Part 4 of Article 26.2. Federal Law of No. 329-FZ of December 4, 2007 "On Physical Culture and Sports in the Russian Federation".

This Regulation is the basis for sending athletes, coaches and other specialists to sports competitions by the executive authorities of the constituent entities of the Russian Federation in the field of physical culture and sports.

#### I. DATES AND VENUE OF THE EVENT.

Competitions are held: r. Smolensk from 09 to 12 June 2025 in SOGAU DS "Yubileyny", 29 Chernyakhovsky St.

#### II. MANAGEMENT OF THE EVENT.

The general management of the competition providence is carried out by the Russian Wrestling Federation. Непосредственное проведение The competition is directly conducted by the main judging panel approved by the Russian Wrestling Federation.

# III. ENSURING THE SAFETY OF PARTICIPANTS AND SPECTATORS, MEDICAL SUPPORT, ANTI-DOPING SUPPORT OF SPORTS COMPETITIONS

Sports competitions are held at sports facilities included in the All-Russian Register of Sports Facilities, in accordance with paragraph 5 of Article 37.1 of Federal Law No. 329-FZ of December 4, 2007.

"On **Physical** Culture and **Sports** in the Russian Federation" that meet the regulatory requirements of the relevant legal acts in force on the territory of the Russian Federation on ensuring public order and safety of participants and spectators, as well the requirements of the rules of competitions in the sport of "wrestling".

Medical examinations of participants in sports competitions carried are out: examination-1-once in-depth medical six months; medical examination before the competition 3-days before the sports competition;

The requirements of this section of the Regulation are specified in the regulations of specific sports competitions.

# IV. TERMS OF THE EVENT.

Competitions are held as individual competitions, according to the current rules of OMB (UWW), approved by the Russian Wrestling Federationin weight categories: 52-62,70, 78, 88, 100 and 130 kg.

Veterans from 35 years of age and older are allowed to participate in the competition according to international rules:

Athletes from other countries are allowed to participate in the competition.

**Division** "A" (35-40 years); **Division** "B" (41-45 years); **Division** "C" (46-50 years); **Division** "D" (51-55 years); **Division** "E" (56-60 years). К участию в соревнованиях также Veterans of division "F" (61-65 years old) and division "G" (66-70 years old), without the right to compete at the World Veterans 'Championship, are also allowed to participate in the competition. Due to the age limit of up to 60 years at the World Veterans Championship, taking into account the recommendations of the UWW Medical Committee and in order to prevent injuries. The age of participants is determined as of December 31, 2024 г.

When passing the credentials committee, team representatives must provide the following documents:

- a registered application with the mark "Admitted" next to each athlete's surname with the signature of a doctor in physical therapy or a doctor in sports medicine and a certified personal seal, if there is a signature with a transcript of the doctor's full name at the end of the application, certified by the seal of the medical organization that admitted the athlete, signed by the head of the physical culture and sports management body;
- an identity document;
- original contract of insurance against accidents, life and health during sports;
- consent to the processing of personal data.
- ECG taken 3 days before the start of the competition.
- Athletes over 60 years of age are allowed to pass the mandatory commission and participate in competitions after completing a personalized agreement on liability, waiver of claims and acceptance of risks (Appendix No. 1).

Participants who do not submit the above documents are not allowed to participate in the competition.

I, on my own behalf and on behalf of my heirs, legal successors, personal representatives and 6closest relatives, **HEREBY RELEASE FROM LIABILITY AND PROSECUTION THE EVENT ORGANIZERS**, their employees, officers, agents, and/or employees, other participants, funding organizations, sponsors, advertisers,
